### Eligibility

The Discovery Center is available to library patrons 13 and older. Children under the age of 12 must be accompanied by an adult over the age of 18 at all times.

All minors must have a User Agreement signed by their parent or guardian.

All users must have a library card in good standing to use the Discover Center. Users must complete and sign the Discovery Center User Agreement before using the Discovery Center.

### Rules of Use

Failure to abide by all policies and procedures will result in suspension or loss of Discovery Center use privileges. For a complete list of policies and procedures please visit the Alhambra Civic Center Library Website.

Users agree to be respectful to all Discovery Center employees and other Discovery Center patrons.

Some of the equipment contain parts or components that could cause injury to the user if library rules, policies, procedures and restrictions are not followed.

Computers and tablets in the Discovery Center are intended to be used with the appropriate equipment and software programs. The library reserves the right to reassign patrons to other computers, if necessary.

The Library does not guarantee the availability of any equipment in the Discovery Center.

The Library is not responsible for any damage that may occur to a patron's materials or project.

The Library reserves the right to terminate a reservation at its discretion.

# Alhambra Civic Center Library Discovery Center User Agreement

## Waiver

I have read and understand this release, indemnification and hold harmless form. I voluntarily sign it and hereby give permission to the Alhambra Civic Center Library for emergency transportation and/or treatment in the event of illness or injury.

I hereby accept responsibility for the payment of any emergency transportation and/or treatment.
